### **II. DFL WALL OF HONOR, HALL OF DISTINGUISHED SERVICE & BUILDING EVENT**

We have sent out invitations to Democrats across the state of Minnesota inviting them to contribute to the DFL Wall of Honor and to attend our dedication event on November 15<sup>th</sup>. All state central committee members and state executive committee members were sent invitations and are asked to forward the information on within your units and to all interested parties. If you lost your invitation or want to refer others, information about the event is available on our website.

In its inaugural year, it is particularly important that we have a good showing. There are people within our districts that have made significant contributions and deserve to be honored. **Please consider making a contribution as a party unit to the wall of honor.** You may choose to honor one of your own local leaders, a state or congressional district party leader or one of the Hall of Distinguished Service inductees. Either way, a contribution from our units to the wall is an important recognition of the many unrecognized individuals who help make our party great.

### III. PRECINCT CAUCUS PREPARATION

By now you should have received a letter outlining the preparations for caucuses that all units should begin thinking about. Essentially, all county unit chairs have the following responsibilities:

- Finding caucus conveners and locations and submitting those to the state DFL office no later than February 3, 2004.
- Making copies (check to cover expenses will be provided) of caucus materials and distributing to caucuses in his/her district.
- Recruiting election judges

More information will be available as we move closer to caucus time.

Also some of you have requested a copy of the state statute regarding usage of public facilities on precinct caucus night. That information is as follows:

#### **202A.192 Use of public facilities.**

Every statutory city, home rule charter city, county, town, school district and other public agency, including the University of Minnesota and other public colleges and universities, shall make their facilities available for the holding of precinct caucuses and legislative district or county conventions required by this chapter. A charge for the use of the facilities may be imposed in an amount that does not exceed the lowest amount charged to any public or private group.

**Olmsted DFL tries to carry on Wellstone's legacy**

In the year since Paul Wellstone died, Olmsted County DFLers have gone from attending vigils in his memory to rallying against state budget cuts to opposing the war in Iraq.

For all the grief brought by his death, his legacy for grassroots organizing lives on locally and throughout the country, said Lynn Wilson, chairwoman of the Olmsted County Democratic-Farmer-Labor Party.

"I think everybody took a little more responsibility and ownership" to be more concerned about the issues, Wilson said.

More people seem to be informed of relevant issues and decisive in their views, she said, adding that state and world events also helped to renew community activism after Wellstone's death in a plane crash Oct. 25, 2002.

"It's just a culmination of the times and the concerns," Wilson said.

The Olmsted County DFL has kept the momentum going by remaining active year-round and increasing its membership, Wilson said. Following last fall's election, the party kept its headquarters open rather than shutting down until the next election cycle.

>From Dec. 5-7, Rochester will be the site of a three-day training event known as "Camp Wellstone." The camps have been conducted in Minnesota and other states in the past year to teach grassroots advocacy and organizing, and to train people how to run a campaign and how to win as a candidate in a progressive campaign.

Wilson said about 135 people are expected to attend the camp, sponsored by Wellstone Action, a non-profit organization devoted to continuing the legacy of Paul and Sheila Wellstone. Registrations for the Rochester camp have already been filled.

Today, local DFLers are observing the one-year anniversary of the Wellstones' deaths by volunteering in the community. Tonight, they'll have a program to honor the Wellstones and raise money from a chili feed for two local charities in their memory.

Both activities are a fitting tribute to the late U.S. senator and his wife, Wilson said.

There's no better way to honor the Wellstones, according to Wilson, than "extending a collective helping hand to the vulnerable and needy in our community."

Other Wellstone supporters will be attending an AFL-CIO convention in the Twin Cities this weekend.

Connie Dammen, president of the Southeast Central Labor Council, said labor organizations are pressing forward with Wellstone's fight to protect the rights of working class people.

"We're carrying the torch," she said.

**Day of Caring and Sharing**

The Olmsted County DFL is having a "Day of Caring and Sharing" as a tribute to the late U.S. Sen. Paul Wellstone and his wife, Sheila. Volunteers performed community service this morning. From 4 p.m. to 9:30 p.m., there will be activities at DFL headquarters, 2002 Second St. S.W. Children's activities will begin at 4 p.m. A chili supper will be from 5 p.m. to 7 p.m. Cost is \$5 per person or \$15 per family. Volunteers eat for free. A tribute to Wellstone begins at 7 p.m. Proceeds from the event will benefit the Women's Shelter and Channel One Food Shelf.
